Applications are invited from eligible candidates for the post of Technical Assistants in different blocks of Leh district as per break up given below:

as supporting staff on contractual basis under MGNREGA for one year extendable further on the basis of performance or till the time funds under the scheme are available. The application should reach this office by or before 31st January 2012.

The terms and conditions for the engagement are as under:-


1. The appointment shall be initially for the tenure of one year extendable further on the basis of performance and it shall be terminable with one months notice from either side but with immediate effect on the basis proven non performance or mis-performance. The candidates with previous experience like the erstwhile Motivators of TSC will also be given due weightage while making the selection.
2. The Qualification for Technical Assistant (Junior Engineer), is Degree/ Diploma in Civil Engineer / Agricultural Engineering / Draftsman course. In case no such candidate is available then IT Civil Engineering shall be considered. Salary of Technical Assistants with Degree in Civil Engineering will be paid Rs. 8500 per month. Those with Diploma in Civil Engineering will be paid Rs. 8000 per month and those with Draftsman Civil Engineering will get Rs. 7500 per month and for ITI holders the salary will be Rs. 7000 per month. The unit of selection shall be Block level but if no qualified candidate is available within the Block concerned then candidates from the District shall be considered.
3. 80% marks will be given for academic qualification and 20% for interview.

OTHER TERMS AND CONDITIONS FOR THE ENGAGEMENT.

1. The maximum age limit for these engagements shall be 45 years. In case of non-availability of candidates or for reasons of higher qualification/ experience, however, 5 years relaxation in the upper age limit can be considered in the age by the selection committee.
1. The arrangement shall be purely contractual and linked inextricably to the availability of funds under Management cost under MGNREGA.
2. The arrangement in the first place shall be made for a period of one year or till the time funds under the scheme are available, whichever is earlier.
3. The arrangement can, however, be dispensed with before the expiry of the period of contract in case of unsatisfactory performance of the candidate as the laid down parameters.
4. The arrangement shall be extendable further on satisfactory performance of the candidate subject to the availability of funds under management cost for the additional staff dedicated to MGNREGA.
5. The performance of the candidate shall be monitored on monthly basis by Director, Rural Development, Srinagar-Kashmir.
