For and on behalf of Governor of Jammu & Kashmir state, sealed tenders affixed with revenue stamps worth Rs 5/= are invited from the Registered agencies/Association for the Planning, Design, Engineering and Civil Construction Works, testing and commissioning of Turtuk – 1 Mini Hydel Project as per table 1 of Shayok Cluster in Nubra Valley of Leh district, on the basis of the minimum qualification criteria stated in the tender document.
2. Complete set of tender documents can be purchased by a written request accompanied by a non-refundable fee of Rs. 8000/- (Rupees Eight Thousand only) in the shape of demand draft drawn in favour of the Project Director, LREDA, payable at Leh. Bidding documents requested by mail will be dispatched by registered/ Speed post on payment of an extra amount of Rs. 1000/ (Rupees One Thousand Only). LREDA will not be responsible for the postal delay, if any, in the delivery of the documents or non-receipt of the same. It would be mandatory for the bidder to pay the cost of the tender documents in the manner specified above by enclosing the demand draft in the cover comprising bid documents alongside the requisite E.M.D.
3. Bids shall be valid for the period of 90 days after Bid opening
4. Bid shall be accompanied by Bid Security (Earnest money ) in Indian currency in the form of a Bank Draft or Bank Guarantee from a nationalized/Scheduled bank pledged to “The Director, LREDA, Leh.
5. Bids must be delivered to the office of the undersigned, complete in all respects on or before the dates prescribed in column 6 of table 1 at 2 pm. Bid will be opened on the same day at 3 pm or any other convenient day, in the presence of the bidders who may choose to attend the opening.
