The tender documents can be purchased from the office of the Deputy Commissioner / Chief Executive Officer, LAHDC Leh against cash payment of Rs. 500/= on any working day up to 02/01/2012.

The tender document should be complete in all respects accompanied with the earnest money deposit of Rs.15,000/- in shape of CDR/FDR from any Nationalized Bank pledged to Deputy Commissioner / Chief Executive Officer, LAHDC, Leh and a Photocopy of PAN and TIN duly authenticated by the authorized signatory. The photocopies of documentary evidence of having filed the latest income tax/ sales tax/VAT returns from the concerned Department along with the requisite rates in the devised format supplied along with the tender document for various key material, should reach to the Chairman, District Purchase Committee (Chief Executive Officer, LAHDC , Leh ) on or before 09-01-2012 upto.3.00 PM and shall be opened on same day or any other day convenient to the Chairman in presence of the tenderers if any.

The terms and the conditions of the contract are as under:

1. The rate quoted should be in words and figures both without over writing/ cutting etc.
2. The rate quoted should be FOR Leh inclusive of all taxes and other surcharges.
3. The successful tenderer shall have to supply the material within a period of 15 days from the date of receiving the supply order.
4. The person signing the tender must indicate his / her registered firm name and No. of SSI unit.
5. In case the successful tenderer fails to supply the material within the stipulated time period and not as per the specifications , his earnest money shall be forfeited and shall be black listed.
6. In case of any dispute the jurisdiction for filing the court case shall be Leh only.
7. The Chairman, District Purchase Committee/ Chief Executive Officer, LAHDC, Leh reserves the right to accept or reject any of the tenders or all tenders without assigning reason thereof.
