

NOTICE INVITING TENDER

No: 41 to 44 of 2011

1. For and behalf of the Governor of the State of Jammu and Kashmir, sealed tenders affixed with revenue stamps worth Rs. 5/- are invited from registered Companies/registered Consortium of Companies/Original Manufacturers of turbine-generator sets for the Planning, Design, Engineering, Fabrication, Supply, Transportation to site, Construction, Erection, Testing, Commissioning and Operation and Maintenance for two years of "Mini Hydel Project on turnkey basis as per Table-1 of MHP Clusters in the Leh District, Jammu and Kashmir on the basis of the minimum qualification criteria stated in the tender document.
2. The complete set of tender documents can be purchased by a written request accompanied by a non-refundable fee of Rs. 10,000/- (Rupees Ten Thousand Only) in the shape of a demand draft drawn in favour of the Project Director, LREDA, payable at Leh. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs. 1000/- (Rupees One Thousand Only). LREDA will not be responsible for the postal delay, if any, in the delivery of the documents or non-receipt of the same. It would be mandatory for the bidder to pay the cost of the tender documents in the manner specified above by enclosing the demand draft in the cover comprising bid documents alongside the requisite Earnest Money Deposit (E.M.D).
3. Bids shall be valid for the period of 120 days after the bid opening
4. Bid shall be accompanied by Bid Security (Earnest Money) in Indian Currency in the form of a CDR/FDR/Demand Draft or Bank Guarantee from a nationalized/scheduled bank pledged to "The Project Director, LREDA, Leh"
5. Bids must be delivered to the Office of the Deputy Commissioner/CEO-LAHDC, Leh-Ladakh complete in all respects on or before the dates prescribed in Column 6 or Table 1 at 2:30 pm. The bid will be opened on the same day at 3:30 pm or any other convenient day, in the presence of the bidders who may choose to attend the opening.
