Sealed tenders affixed with Revenue Stamps worth Rs. 5/- (Rupees Five only) are invited by the Chairman, District Purchase Committee, Leh on behalf of the Governor of Jammu and Kashmir from the Authorized Distributors/ Dealers/ Agents/Stockiest for the supply of " **Local Barley** " which is to be purchased under the Centrally Sponsored Programme of Nutrient Supplement of scheme Sheep and Wool improvement- Integrated Wool Improvement Programme 2011-12. The detailed tender documents can be had from the office of the District Sheep Husbandry Officer, Leh against a cash payment/Demand Draft worth **Rs. 100/-** (Rupees One hundred only) favouring District Sheep Husbandry Officer, Leh, upto **19th of September, 2011** upto 4 p.m. The tender documents duly completed in all respect addressed to the Chairman, District Purchase Committee, (Deputy Commissioner), Leh should reach to the office of District Sheep Husbandry Officer, Leh by or before **21st of Sept 2011 up to 2 P.M.**, and the same shall be opened either on the same day or any other day convenient to the Members of District Purchase Committee, Leh, in presence of the tenderers/ their authorized representatives who may like to be present at the time of opening of the tender. An earnest Money to the tune of **Rs. 15,000/-** (Rupees Fifteen thousand only) in the shape of CDR/FDR of any Nationalized Bank duly pledged to the Chairman, District Purchase Committee, Leh shall have to be enclosed along with the offer, without which the tender /offer shall be rejected out rightly.

The Chairman, District Purchase Committee (Deputy Commissioner/CEO, LAHDC), Leh reserves the right to accept or reject any tender without assigning any reasons thereof.



Details of terms and conditions:-

1. The tenderers should carefully examine the conditions of the items to be supplied wherever applicable. In case of any doubt the tenderer should before signing the contract, refer the matter to District Sheep Husbandry Officer, Leh for clarifications.
2. The tenders addressed to the Chairman, District Purchase Committee (Deputy Commissioner/CEO,) Leh should be submitted in proper sealed envelope duly marked as "**Local Barley**" which should reach to the office of the District Sheep Husbandry Officer, Leh by or before, **21st of Sept 2011 upto 2 P.M** , which shall be opened either on the same day or any other day convenient to the Committee in presence of the Tenderers/their authorized representatives who may like to be present at time of opening. The tenders received after the due date and time shall not be accepted.
3. The tender should be accompanied by an Earnest Money to the tune of **Rs. 15,000/-** (Rupees Fifteen Thousand only) in the shape of CDR/FDR of any Nationalized Bank pledged to the Chairman, District Purchase Committee, Leh without which the tender shall be rejected outrightly. The Earnest Money in respect of unsuccessful tenderers shall be released after finalization of the contract/acceptance of the tender.
4. The rates should be written in words and figures without cutting and over writings. Moreover the rates should be quoted FOR Stores of Sheep Husbandry Department at Leh.
5. The successful tenderer shall have to furnish security deposit @ 5% of the total value of the contract/supply order less by Earnest Money already furnished. The rate contract shall remain valid for one year from the date of issue of rate contract. Price escalation during the contract period shall not be allowed in any case.
6. The tender should be written neat and clean without cuttings/overwritings.
7. The envelope containing tender should be marked as "**Tender for Local Barley**"
8. The supplies should be executed within a period of 45 days from the date of issuance of confirmed supply order.
9. The successful tenderer shall have to execute an agreement with the concerned authorities of Sheep Husbandry Department, Leh within 10 day's from the date of issue of supply order failing which the payment shall not be released.
10. All the terms and conditions of the NIT shall also form a part of supply order and agreement.
11. The successful tenderer shall have to abide by the standard terms and conditions of contractual obligations as laid down in J&K Financial Code/Rules and the conditions as per the contract.
12. The successful tenderer shall be responsible for execution of contract in full and shall not in any case assign or sublet the approved items or part thereof to any other party. Suitable penalty upto 10% of the total value of the contract shall be imposed for any such deviation from contractual obligation on merit of each case, which can be recovered from Earnest Money/ Security Deposit, which can lead to the debarring/black listing of the supplier/firm/dealer /original manufacturers for submitting their tender in future at Leh.
13. The tenderer shall be responsible for the proper packing of the material, so as to avoid damage under normal conditions of the transport by road or air and delivery of material in good condition to the consignee at the destination. In the event of any loss, damage breakage, leakage or any shortage found on checking/ inspection/verification of the material by the consignee, the supplier shall be responsible for the same.

14. If the approved supplier fails either to supply the goods of prescribed specification or to deliver the goods within specified period, the Chairman District Purchase Committee Leh shall be at liberty to arrange supplies either through re-tender or otherwise after giving notice to the approved supplier, the Earnest Money deposit and other deposit, if any available with the Deptt shall be retained to make good any loss or extra cost incurred by the department in procurement of those supplies.
15. The supplies shall be verified by the Committee of Officers constituted for the purpose and the Committee reserves the right to reject any of the stock supplies, if it is found sub standard and damaged or not conforming to the required specification.
16. 100% Payment shall be made on receiving of supplies, but it will be subjected to the report of Verification committee and also availability of funds.
17. In case of any dispute/difference or doubts between the purchasing officer and approved supplier, the order of the Chairman, District Purchase Committee, Leh shall be final and binding on both the parties.
18. The quantity shown in the tender form, if any is tentative and may be increased/decreased or deleted. It will depend on the actual requirement of material based on availability of funds. It shall not be obligatory on the department to purchase the advertised quantity in part or full.
19. The Chairman District Purchase Committee Leh reserves the right to accept or reject all tenders/any tender without assigning any reasons thereof.
